Each Pack also contains Emergency Procedures and Injury / Accident Forms.

- THE DEPARTMENT OF LABOUR NOTIFICATION FORM



SITE HAZARD BOARD

HazardCo will provide an 800 x 600mm Hazard Board for builders. The Hazard Board informs all people of the current hazards before they enter the worksite. Contractors will only need to list any additional hazards on the Hazard Board, that they identify during the building process (if any).

The back of the Hazard Board contains simple safety images designed to remind workers of the most significant safety issues.
